





Sport / Discipline


Interest of sport by general public






ResultsIndicator 8b – Favourite Sports Among the Youth Sport/Discipline

i10 IF-OWNED SOCIAL MEDIA PERFORMANCE




This is designed to acknowledge and measure the relative performance of the International Federations' owned social media activity during Games time. In order to do this, an application known as Socialtools was used.

It tracked the daily competitive performance of any social media pages, and searches billions of posts and comments across 185 countries for Facebook, Twitter, Instagram and YouTube monitoring the specific platforms indicated in advance by the respective IFs.


i10 IF-OWNED SOCIAL MEDIA TOTAL SCORE

World Cup Final

Decision requested: Put a deadline of 31st January for an official bid to be made by the countries concerned and a decision by postal vote early February

- Costs of supervising world ranking tournaments in terms of ITA
 Add 780 CHF to the 1500 CHF for the costs of management by ITA of doping control program
- Issue with World Ranking tournaments that did not respect 6-month deadline
 A late entry fee of 500 CHF will be added to the invoice for non-respect of the deadline and in future these countries will not be accepted
- Quality of results teams used in certain multisport events
 Decision: to put in place a certification system of results providers for multisport games to ensure the quality of the events

Procedures for World Cups





The proposed programme with a single session of official practice for 4 hours for all categories is not giving enough time to proceed as a calling per country as we currently do.

The idea would be to have athletes having free access to the equipment inspection area to have their equipment checked by their judges during that period. All athletes not going through that equipment inspection may be subject to equipment inspection during the event itself.

In case any infringement to the rule is noted, the athlete would have to proceed with fixing it on the spot and immediately.

Current equipment inspection allows to check uniform and equipment but does not prevent efficiently against a change of equipment during the competition itself.

International licence



Art 2.1.1 Athletes, coaches and officials who wish to participate in Championships, Games, International and National Tournaments, which are recognised or controlled by World Archery or a Member Association, in one or more of the various disciplines recognised by World Archery, shall be affiliated with a Member Association and have a valid international license (until such time that the Executive Board adopts bylaws as to international license requirements, an athlete's, coaches' and official's membership in his Member Association shall constitute a valid international license.)

NOT NEW - This was approved by the Congress in 2017 and 2019

The reason for the delay was to find the right insurance partner

We will work with IMSSA – who is working with FIG (Gymnastics), UWW (Wrestling), FIS (Skiing), FIFA, FIVB (Volleyball), PanamSports, ANOC, ITTF (Table Tennis), IIHF (Ice Hockey) and many others

Introduction for 2022 an international licence for all World Ranking tournaments and World Championships (so this is for 2022 including World Championships 3D and Field)

Cost: 100 CHF

Includes:

- Travel and health insurance
- Registration would be through the accreditation process and the invoice would be at the end of the year like for calendar tournaments and membership fees
- A digital certificate of the licence will be available

Time limit



Following the comments a two step approach:

- World Ranking Tournaments as of 1st March 2022
 - As requested by Athletes Committee new rule applies
 - WA Americas confirmed also for Youth/Master Event. Europe waiting news on Junior Cup
- Other events Rule prior to 18th September applies but C&R and TAC are mandated to come with a proposal to clearly define exceptional circumstances so that some of the issues raised for national events can be solved by 1st March 2023.
- For Para- team rounds same as for Able bodied team rounds!!!

Bylaws and procedures



Time limits

12.2.1 The maximum time permitted for an athlete to shoot an end of three arrows is two minutes. The maximum time permitted for an athlete to shoot an end of six arrows is four minutes.
13.4 Shooting Time and Time Limits:
—13.4.1 120 seconds is the time allowed for an athlete to shoot one arrow (including shoot-off) when shooting alternately in the Olympic, Compound and Indoor Match Round matches.
13.4.2.30 seconds is the time allowed for a para-athlete to shoot one arrow (including shoot-off) when shooting alternately in match play in a Para Archery Event
13.4.3 40 seconds is the time allowed:
To make up one arrow; For an athlete to shoot one arrow in order to break ties; For the Mixed Team to shoot their two arrows for the purpose of breaking ties.
—13.4.4 One minute is allowed for a team to shoot three arrows; one per athlete in the Team Round for the purpose of breaking ties:
—13.4.5.80 seconds is allowed for a Mixed Team to shoot four arrows, two per athlete.
13.4.6 Two minutes is the time allowed for an athlete to shoot an end of three arrows or for a team to shoot six arrows:
13.4.7 Four minutes is the time allowed for an athlete to shoot an end of six arrows.

- 13.4.1 The total time allowed to shoot an end shall be determined by the total number of arrows to shoot in an end, where:
- 13.4.1.1 For World Ranking Events:
 - 20 seconds per arrow is the time allowed for individual alternate shooting, and for all team and mixed team rounds including shoot-offs;
 - 30 seconds per arrow is the time allowed for individual shooting during qualifications, Olympic round and Compound rounds where alternate shooting does not apply, including shoot-offs;
 - For all para-archery individual rounds at Para Archery World Ranking Events, the time per arrow shall be extended by 10 seconds for all situation aforementioned
- 13.4.1.2 Transitional rule for all other events until 1 March 2023
 - 20 seconds per arrow is the time allowed for individual alternate shooting (30 seconds for para-archery), and for all team and mixed team rounds including shoot-offs;
 - 40 seconds per arrow is the time allowed for individual shooting during qualifications, Olympic round and Compound rounds where alternate shooting does not apply, including shoot-offs;
- 13.4.8 2 The time limit may be extended in exceptional circumstances.
- 13.7.1 In the Individual Event the time per arrow foreseen in the articles 13.4.1 and below shall be given in the Olympic, Compound and Indoor Match Rounds.

Judges Committee

The Judges Committee would like to request that the number set by the Board, in accordance with article 5.1.3, be raised from 70 (current number) to 80

The judges committee has agreed that this should only be used to have more women and to reduce the average age of the judges. This will be closely monitored

Target Committee

Remove the equipment failure rule for qualification/ranking rounds

- 12.2.4 In the event (during the qualification round) of an equipment failure, verified by a Judge, or a medical issue, verified by medical personnel, extra time may be given to make the necessary repairs, change the damaged equipment or for medical personnel to determine the problem and decide whether or not the athlete is fit to continue competing unassisted. However the maximum time or number of ends for make up arrows to be shot is 15 minutes (following regular order of shooting and timing), or two ends of six arrows outdoors and three ends of three arrows indoors, whichever happens first. The athlete shall make up the appropriate number of arrows at the earliest opportunity under the supervision of a Judge. 12.2.4.1 In the event of an equipment failure the athlete shall call a Judge while stepping back from the shooting line. 12.2.5 The order of shooting may be changed temporarily for the purpose of an equipment repair or for medical treatment. 12.2.6
- 12.2.4 In the Olympic, Compound or Indoor Match Round, No extra time shall be allowed for equipment failure or the treatment of medical problems, but the athlete concerned may leave the shooting line to resolve the issue and return to shoot any remaining arrow(s) if the time limit permits. In the Team Event other member(s) of the team may shoot in the meantime. 12.2.7
- 12.2.5 The arrows of individual athletes or teams with byes or forfeited matches shall not be scored and they shall advance to the next round.
 At International Events they may practise on the practice field or the unused portion of the competition field. For other competitions they may practise on the assigned targets unless another adjacent practice field is available. 12.2.8
- 12.2.6 Practice on the competition field during byes, for individuals, will be limited to three arrows per end and maximum of three sets for recurve and barebow, and five ends for compound. In case of teams, it will be limited to six arrows (2 arrows per athlete) per end and a maximum of three sets for recurve and barebow, and four ends for compound. If more than the mentioned number of arrows is shot by an athlete or a team in an end after being warned by a judge, the athlete or team may be denied further practice on the competition field but any such violation shall not affect the next match

Art 3.12.1The Judges' duties are to ensure that the tournament is conducted according to the Constitution and Rules, and in fairness to all athletes.

Using Stabiliser in Barebow?

A stabilizer is not allowed. 22.3.6.1. and 11.4.6.1. Vibration dampeners fitted as part of the bow are permitted provided that they do not have stabilisers.

Vibration dampeners are permitted. They may be installed in the riser by the manufacturer, or by attaching aftermarket dampeners directly to the riser or to weight(s). Any combination of weight(s) and vibration dampener(s) must pass through a ring with an inside diameter of 12.2 cm (+/- 0.5mm) without having to flex vibration dampeners to fit through the 12.2 cm ring. A riser manufacturers angled stabilizer insert(s) are allowed, but angular brackets or connectors are not permitted. Weight(s) and dampener(s) may be added below and above the riser's grip, but must not aid the athlete in aiming or ranging in any way
